MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding (MOU) made on this 26th day of February 2016 at Patna (Bihar) between:

1) *The Governor of Bihar* represented through the Labour Commissioner, Labour Resources Department, Government of Bihar, Patna (hereinafter referred to as 'Government of Bihar' which expression shall unless the context otherwise requires, be deemed to include its successors and the assigns).

AND

2) *State Bank of India*, a body corporate, incorporated under the State Bank of India Act 1955, having its Corporate Office at 'State Bank Bhavan', Madame Cama Road, Nariman Point, Mumbai-400021 and represented through the General Manager (Net

- 3) WHEREAS SBI carrying on, inter-alia, Banking Business is presently collecting as Accredited Banker Registration/Renewal of License fee payable by the customer to the Government of Bihar through its Focal Point Branch i.e. Bailey Road Branch and has now agreed to provide the facilities for e-payment of such Registration/renewal of License fee as per the Terms & Conditions set out hereafter.
- 4) Government of Bihar and SBI are desirous of entering into an agreement whereby the customers will be provided with a facility of making their payments towards online fee payment and will be provided with one or more of the following facilities:
 - i) Internet Banking of SBI and other Bank.
 - ii) Debit and Credit Card of all Major Banks.
 - iii) Physical Mode through Cash/Cheque
- 5) AND WHEREAS NIC Bihar has given its commitment to access the state government website www.bihar.gov.in and prepare and maintain necessary software for integration of the website with site designated by SBI for purpose of electronic payment of fee as given hereinafter. This site will be integrated with
 - i) Payment Gateway Facility for Maestro, Master Card, VISA -both Debit & Credit Cards of all major Banks.
 - ii) Internet Banking of SBI and other bank's through SBMOPS.
