The provisions have been made for registration and renewal of establishments / factories under different labour laws, but the time limit was not fixed earlier for the disposal of applications under these acts.

Since the system of submitting application for registration / renewal has been started online for the speedy disposal of the application, an administrative decision has been taken to fix the time limit for disposal under various labour laws, as below:-

| S.No | Name of the Acts & Rules | Time fixed for registration / license |

| 1 | Disposal of applications for registration under Bihar Shops & Establishment Act, 1953 sec 06, Rule 3(1) of the BSE Rules 1955 | 15 working days |
| 2 | Disposal of applications for certificate / renewal under Sec 07 & 08 of Boiler Act, 1923 | 15 working days |
| 3 | Disposal of application under Sec 06 of Factories Act, 1948 and Rules 4,5,6,7,8 of Bihar Factories Rules 1950 | 15 working days |
| 4 | Disposal of application under sec 12 of Contract Labour (Regulation & Abolition) Act, 1970 and Rule 21 of Bihar Contract Labour (Regulation & Abolition) Act, 1972 | 15 working days |
| 5 | Disposal of application for registration of Construction Workers under sec 12 of Building and other Construction Workers (Regulation of Employment and Condition of Service) Act,1996 and Rule 266 of Bihar Building and other Construction Workers (Regulation of Employment and Condition of Service) Rule 2005. | 15 working days |
| 6 | Disposal of application for registration under Sec 3 of Motor Transport Workers Act, 1961 and Rule 4, 6 of Bihar Motor Workers Rules, 1962 | 15 working days |
| 7 | Disposal of application under section 4, (Rule 5) of Bidi & Cigar Workers Act, 1966 | 15 working days |

Time limit will be calculated after the receipt of online application based on working days. In case of incorrect / incomplete or less fee, or due to other reasons if the application is rejected, the registering / licensing officer will communicate the same to the applicant in prescribed time.
